Preparation for Colonoscopy- Halflytely

No ASPRIN, IBUPROFIN, IRON, or VITAMIN E should be taken for at least 7 days prior to colonoscopy. Patients on COUMADIN, PLAVIX, PERSANTINE should discontinue it 3 to 5 days prior to the colonoscopy, WITH THE CONSENT of their cardiologist/internist. IF THERE ARE QUESTIONS, PLEASE CHECK WITH OUR OFFICE. If you are unsure of other medications you may be taking, CHECK WITH OUR OFFICE. TYLENOL AND/OR MULTIVITAMINS ARE ALLOWED.

1. On ______ morning, fill HALFLYTELY jug to the dotted line with tap water and refrigerate. Start your clear liquid diet the day before the procedure. Your liquid diet may consist of: strained fruit juices without pulp (apple, white grape, lemonade), Gatorade, carbonated and non-carbonated soft drinks, Kool-Aid (or other fruit-flavored drinks), clear broth or bouillon, plain Jello (without added fruits or toppings), ice popsicles, coffee or tea and water. Do not take red or purple liquids or Jello. Do not take tomato juice, dairy and nothing should contain seeds or nuts.

2. At 6:00 PM, take the four bisacodyl tablets (you will find them in the Halflytely box) with 8 ounces of water. You should be at home or have a bathroom available to you.

3. At 9:00 PM, begin to drink the Halflytely solution. Drink an 8 ounce glass every ten minutes until the entire contents of jug are consumed. Rapid drinking of each portion is preferred rather than drinking small amounts continuously.

4. Clear liquids are allowed until (3) three hours prior to the procedure.

NOTE: Since you will be unable to drive after the procedure, please have a driver accompany you. You may not drive a vehicle until the next day.
